# **WASD COLLABORATION WITH THE UNITED NATIONS**

WASD is delighted to have been working very closely with various United Nations Agencies, most specifically with the UN Joint Inspection Unit (JIU). Both JIU and WASD are inspired by the conviction that the UN Agenda 2030 for Sustainable Development (SD) and the 17 Sustainable Development Goals (SDGs) provide the momentum for renewed UN engagement with the public and private sectors.

In 2018, WASD collaborated with JIU on the UN project **Strengthening policy research uptake in the context of the 2030 Agenda for Sustainable Development**, aimed at reviewing the policy research uptake in service of the 2030 Agenda for SD. For the first time in its 52 year history, the UN (aided by WASD) officially consulted academics and researchers from all over the world on the policy research uptake in the UN.

In 2019, WASD also worked very closely with the UN JIU to undertake a UN system-wide review of policies, programmes, and platforms to support learning and enhance the adequacy of training policies in the UN. The report **Policies and platforms in support of learning: towards more coherence, coordination, and convergence** was launched officially on 28 October 2020 at the opening of WASD's Online Learning Conference.

These various initiatives and events with the UN JIU have encouraged WASD to launch its **Sustainable Development Goals Universities Initiative (SDGsUNi).**

# **SDGS UNIVERSITIES INITIATIVE**

In May 2020, WASD established the Sustainable Development Goals Universities Initiative (SDGsUNi). ALLAM is a Professor of Knowledge Management and Sustainable Development; Founding President of (WASD) (2003); Founding Director of SDGsUNI (2020); Founding Director of Middle Eastern Knowledge Economy Institute (2012); Founder, in collaboration with the UNESCO Chair on Transfer of Technology, the International Diaspora Initiative/Sudan Knowledge (2008); early 2022, Professor Ahmed joined Queen Mary University of London as an Honorary Professor (Faculty of Medicine and Dentistry) and Senior Policy Fellow (Global Policy Institute). Prior to QMUL, Allam was the Co-Director for the University of East London Centre for Islamic Finance, Law and Communities (2019-2020). He spent 15 years (2004-2019) at the University of Sussex Science Policy Research Unit (SPRU) where he established and led Sussex's most successful postgraduate programme MSc International Management. In the period 2009-2011, Professor Ahmed led the Government of Abu Dhabi major and first of its kind in the UAE and MENA region Knowledge Management Framework (Musharaka). Professor Ahmed has published widely, covering various disciplines. He has produced more than 120 publications, including 39 books and numerous articles in international peer-reviewed journals, books, conferences proceedings and working papers, all rated as world-leading and internationally recognised. He completed his PhD in Economics in two years at Edinburgh Napier University, UK, and was awarded the Royal Agricultural University (RAU) Scholarship and Prestigious Book Prize for Best MSc/MBA Dissertation. He is a Fellow (FCIM) and Chartered Marketer of the Chartered Institute of Marketing and Fellow (FFPH) Faculty of Public Health, UK. Professor Ahmed is listed in the Who's Who in the World 2009-2021, and received the 2021 Who's Who in the World Lifetime Achievement Award. He is also listed in Who's Who in Finance and Business 2009/2010, and Who's Who in America 2012-2014 published by Marquis Who's Who, USA.



### **Professor Beverlee B. Anderson (United States)**

**BEVERLEE** has been an academician for most of her life. After being awarded Professor Emerita status by California State University San Marcos, she has continued to expand her knowledge through continuing education and theoretical and applied research primarily in the fields of business. Recently she completed a four-year Certificate program of liberal studies at the University of Chicago, which has added new dimensions to her professional endeavors. She began her academic career after receiving her MBA and Ph.D. from Ohio State University. Early in her academic career she held teaching

positions at the University of Kansas and University of Cincinnati, later she held faculty and administrative positions at Wright State University, where she was Director of a Consumer Research Center and Chair of the Marketing Department. She served as Dean of Business at University of Wisconsin-Parkside and later at California State University San Marcos. Returning to a faculty position, she became acquainted with WASD and the concept of Sustainable Development. Since that initial introduction she has expanded her research to include the role of corruption on economic development and continues to research and write about various technological and social changes that have impact on the potential achievement of SDGs. She has taught as a visiting professor in graduate business programs in Mexico and India. She is past President of Marketing Educators Association and actively served as a Board member and officer in several International Business organizations. Her academic publications and presentations have focused on cross-cultural and international business areas including sustainable development.

### **Professor John Adams** (United Kingdom)




#### Dr Vikram Murthy (New Zealand)

Ihab has developed an independent research career that underpins the pivotal role of medical nutrition in regulating complications of chronic diseases through Tailored Functional Recipes (TFRs). These innovative TFRs are formulated, optimized using locally food ingredients and served as meals to nourish vulnerable populations to attain optimum health. The TFR-concept is not limited to elimination of malnutrition but

extend to the design and engineering of food that transcends disease prevention by improving availability of micronutrients, increasing biological functions, and promoting sustainable health. Such concept has been employed to modulate global chronic disease in Georgia, Nigeria, Ghana, India, Lebanon, Nepal, Qatar, Kuwait and UK. Dr Tewfik has led the Human Nutrition degree at University of Westminster over the last twelve years as Programme Director. His research portfolio spans to investigate the relationship between obesogenic environment and health outcomes of individual and population. His work embraces the effects of nutritional exposure during childhood and risk factors for later non-communicable diseases (NAFLD, PCOs, ADHD, CVD, DM, Cancer) especially in countries experiencing nutritional transition. As Fellow of the Royal Society of Public Health (FRSPH), Ihab has been at the forefront of promoting global public health intervention with an international research agenda stretched to 11 research projects with UNICEF-UN in aspects of public health nutrition intervention. In UK, he has carried out three national projects on food safety (FSA-UK) and on Biomarkers for predicting breast radiotherapy induced side-effect funded by the National Cancer Research Institute.


